
Green-Rainbow Party Agent Agreement

This Agent Agreement is made this _____ day of the month of _____, in the year 20____.

I. Definitions:

- A. PARTY shall mean the Green-Rainbow Party (previously known as the Massachusetts Green Party)
- B. PUBLICATION shall mean either the Commonwealth's voter registration information, or the PARTY's financial supporter and contact information, or both, in any form, electronic or printed
- C. AGENT shall mean a person working on behalf of the PARTY, as allowed by the PARTY's policies, to receive the PUBLICATION to aid in growing the party, who is registered as a Green-Rainbow Party voter in the state of Massachusetts
- D. AREA shall mean the towns, cities, counties, or regions that the AGENT will be working to grow the party

II. Agreement

The PARTY is providing to the AGENT, an individual named (print name)

to aid in growing the PARTY. At no time does AGENT own the PUBLICATION nor is this an exclusive use of the PUBLICATION by the AGENT. AGENT will receive the part of the PUBLICATION that pertains to the AREA described as the towns, cities, counties, or regions of:

The AGENT is liable and will compensate the PARTY for any and all damages that may result to the PARTY for misuse by the AGENT.

Allowed uses and required handling of the PUBLICATION by the AGENT are outlined in attachment A. If AGENT is unclear if a proposed use of the PUBLICATION is allowed or disallowed, AGENT will contact PARTY for a determination rendered by a decision of the Administration Committee. No other use of the PUBLICATION is allowed. Allowed uses may change according to policy.

If AGENT is found by the PARTY to be misusing the PUBLICATION in a manner that is not expressly permitted as specified in attachment A, the AGENT will return all paper copies of the PUBLICATION to the PARTY, delete all electronic copies, and cease and desist all uses of the PUBLICATION.

Appendix A: Allowed Uses and Required Handling of the PUBLICATION**I) Allowed Uses**

An AGENT may use the PUBLICATION to do mailings, phone banks, and door to door canvassing for the express purposes of building the party which includes:

- 1) Starting a PARTY local in the area
- 2) Growing a PARTY local in the area
- 3) Doing outreach and organizing for a Regional or a State Convention
- 4) Voter Registration activity
- 5) Performing sanctioned work for an officially recognized working or standing committee of the State Committee
- 6) Performing fundraising for the PARTY as an official independent contractor
- 7) Locals doing outreach for a PARTY candidate or independent candidate (registered Unenrolled) endorsed by a local

II) Required Handling

Where provided by the PARTY, AGENT agrees to maintain any unique indices for the PUBLICATION. Maintaining such unique indices will assist both the AGENT and the PARTY when updating their respective copies of the PUBLICATION.

When requested by the PARTY, the AGENT must share any updates to the PUBLICATION that the AGENT makes. The AGENT must transmit such updates to the PARTY within ten business days of receiving a request from the PARTY.

When an AGENT contacts a person from the PUBLICATION, if the person wishes to no longer be contacted, the AGENT must ensure that this person's desire is upheld, and annotated in the PUBLICATION. This information is essential to relay back to the PARTY in a timely manner.

The AGENT may request updates to the PUBLICATION from the PARTY. While this agreement is in force, the PARTY must transmit such updates to the AGENT within ten business days of receiving a request from the AGENT.

AGENT is responsible to ensure the security and confidentiality of the PUBLICATION at all times.
